The meeting will be held on Monday, May 1, 2017, at 6:00 p.m.

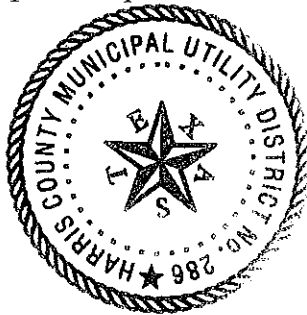
The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the April 3, 2017, and April 17, 2017, Board of Directors meetings;
2. Harris County Constable's security patrol report;
3. Consider status of security monitoring services, and the taking of any actions required in connection therewith;
4. Developer's reports, including updates on status of development and provision of services to:
  - a) Hewlett-Packard ("H.P.");
  - b) Genesis Capital Partners, L.L.C.;
  - c) Centre at Cypress Creek ("Centre");
  - d) Lone Star College System ("Lone Star");
  - e) Compaq Center Drive West Owner's Association ("CCDWOA");
5. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
6. Operator's Report, including:
  - a) Appeals of District charges;
  - b) Refer accounts for collection and approving write-off of uncollectible accounts;
  - c) Report regarding status of maintenance projects, and take any action in connection therewith;
7. Consider approval of Consumer Confidence Report and authorize distribution to consumers;
8. Engineer's Report, including:
  - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts,

including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposed, acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and status of street and storm sewer acceptances by Harris County;

- i) approval of plans and specifications and authorize advertisement for bids for the lift station rehabilitation project;
  - ii) review of bids and award of contract for installation of generators at District lift stations;
  - iii) status of contract with T Construction, LLC for water and sanitary sewer to serve Lone Star Science Building;
  - b) Status of the North Harris County Regional Water Authority (“Authority”);
  - c) Status of site work, inspections, and/or permitting with respect to Lone Star Property, Centre Property, Five Chasewood Property, and HP Property;
  - d) Report regarding maintenance of park property and trails and consider authorizing repairs relative to same; and
  - e) Consider playground equipment safety report;
9. Consider discussion on and take appropriate action related to trail repairs, including action regarding easement acquisition from Terpstra;
  10. Bookkeeper’s report, including financial and investments reports, and taking of any action required in connection therewith, including authorizing the payment of invoices presented;
  11. Consider approval of Water Supply Contract by and between the District and SIR NE Houston LLC, and the taking of any items required in connection therewith;
  12. Consider request from Greater Houston Off-Road Biking Association regarding trail maintenance; and
  13. Matters for possible placement on future agenda.
