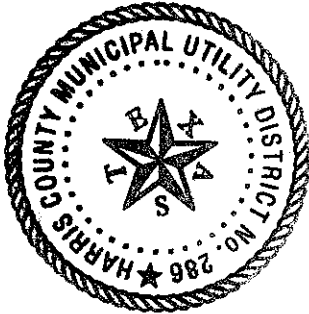
The meeting will be held on **Monday July 6, 2015, at 6:00 p.m.**

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the June 1, 2015, Board of Directors meetings;
2. Harris County Constable's security patrol report;
3. Developer's reports, including updates on status of development and provision of services to:

 - i) Discussion concerning assessment of surcharge payments by Chasewood Water Supply Corporation ("CWSC");
 - c) Centre at Cypress Creek ("Centre");
