NOTICE OF PUBLIC MEETING

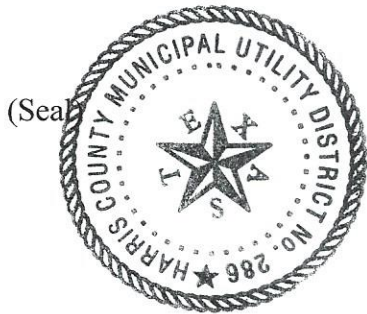
Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 12779 Jones Road, Houston, Harris County, Texas 77070, said address being a meeting place of the District.

The meeting will be held on Monday, May 6, 2019, at 6:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the April 1, 2019, Board of Directors meeting;
2. Consider Harris County Constable's security patrol report, and the status of security monitoring services, and the taking of any actions required in connection therewith;
3. Developer's reports, including updates on status of development;
4. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
5. Operator's Report, including:
 - a) Appeals of District charges;
 - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
 - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
6. Consider approval of Consumer Confidence Report and authorize distribution to consumers;
7. Engineer's Report, including:
 - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposes, acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and status of street and storm sewer acceptances by Harris County;
 - i) status of construction contract with T&C Construction, Ltd. for the lift station rehabilitation project;
 - ii) approval of plans and specifications and authorize advertisement for bids for replacement of lift station control panel;
 - iii) award of construction contract for improvements and flood mitigation at the Wastewater Treatment Plant;
 - b) Status of the North Harris County Regional Water Authority ("Authority");
 - c) Report on operation of flare;

- d) Report regarding maintenance of park property and trails and consider authorizing repairs relative to same; and
 - e) Status of FEMA claims for Hurricane Harvey damages;
8. Consider amendment to contract with Brian Gardens to remove costs related to trail maintenance;
 9. Consider discussion regarding Cypress Creek Flood Control Coalition and Harris County flood mitigation efforts, and the taking of any actions required in connection therewith;
 10. Bookkeeper's report, including financial and investments reports, and taking of any action required in connection therewith, including authorizing the payment of invoices presented;
 11. Matters for possible placement on future agenda.
