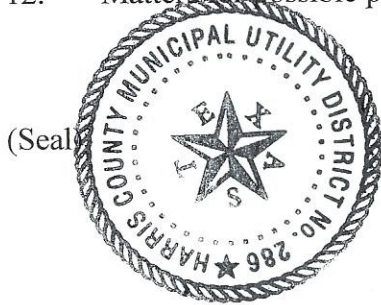
The meeting will be held on Monday, October 4, 2021, at 6:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the September 7, 2021, Board of Directors meeting;
2. Consider Harris County Constable's security patrol report, and the status of security monitoring services, and the taking of any actions required in connection therewith;
3. Consider comments from members of the public;
4. Conduct a public hearing relative to the District's proposed maintenance and operations tax for 2021;
5. Consider the adoption and levy of the District's maintenance and operations tax for 2021, and the adoption of an Order in connection therewith;
6. Consider the approval and execution of an Amendment to the Second Amended and Restated District Information Form;
7. Consider engagement of auditor for the fiscal year ended September 30, 2021, and the taking of any action required in connection therewith;
8. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
9. Operator's Report, including:
  - a) Appeals of District charges;
  - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
  - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
  - d) Review proposals for automatic bar screen repairs at the Wastewater Treatment Plant;

  - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposes, acceptance of site and/or
