Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 13850 Cutten Road, Houston, Harris County, Texas 77069, said address being a meeting place of the District.

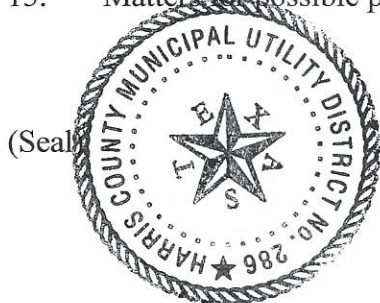
The meeting will be held on Monday, October 3, 2022, at 6:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Review and consider approval of the minutes of the September 6, 2022, Board of Directors meeting;
2. Consider Harris County Constable's security patrol report, and the status of security monitoring services, including ratification of Board's prior action approving Interlocal Agreement for Law Enforcement Services between Harris County and the District, and the taking of any actions required in connection therewith;
3. Consider comments from members of the public;
4. Conduct a public hearing relative to the District's proposed maintenance and operations tax for 2022;
5. Consider the adoption and levy of the District's maintenance and operations tax for 2022, and the adoption of an Order in connection therewith;
6. Consider the approval and execution of an Amendment to the Second Amended and Restated District Information Form;
7. Consider engagement of auditor for the fiscal year ended September 30, 2022, and the taking of any action required in connection therewith;
8. Consider discussion regarding the status of solid waste collection and recycling services from Texas Pride Disposal, and take appropriate action relative to same;
9. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
10. Consider status of insurance and FEMA claims relative to Hurricane Harvey damages;
11. Operator's Report, including:
 - a) Appeals of District charges;
 - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
 - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
 - d) Review proposals for mass communication service;
 - e) Discuss water conservation efforts;

 - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of facilities for operation and maintenance purposes, and acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - i) Status of construction contract with CFG Industries, LLC for clarifier repairs at the Wastewater Treatment Plant;
 - b) Status of the North Harris County Regional Water Authority ("Authority");
 - c) Report on operation of flare from Patriot and approval of amended contract in connection with same;
 - d) Report regarding maintenance of park property and trails and consider authorizing repairs relative to same;
 - e) Consider review of quotes for replacement of booster pump no. 1 at Water Plant;
 - f) Consider status of permit renewal for WWTP Discharge Permit;
 - g) Consider update on Microgrid implementation;
14. Bookkeeper's report, including financial and investments reports, and taking of any action required in connection therewith, including authorizing the payment of invoices presented;
15. Matters for possible placement on future agenda.
