The meeting will be held on Monday, December 5, 2022, at 6:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

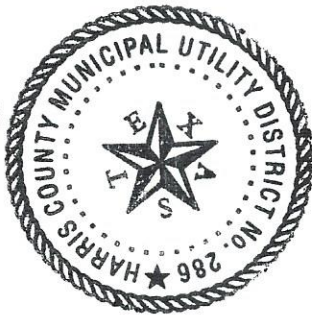
1. Review and consider approval of the minutes of the November 7, 2022, Board of Directors meeting;
2. Consider adoption of Resolution Adopting List of Qualified Brokers Authorized to Engage in Investment Transactions with District;
3. Consider presentations from brokerage firms, authorize District to enter into contract with same for the purchase of securities, and authorize wires for purchase of same;
4. Consider discussion regarding electricity contract with Direct Energy Business, LLC, and the taking of any actions in connection therewith;
5. Consider Harris County Constable's security patrol report, and the status of security monitoring services, and the taking of any actions required in connection therewith;
6. Consider comments from members of the public;
7. Tax Assessor-Collector report, including status of delinquent tax accounts, and the taking of any action in connection therewith, including authorizing the payment of invoices presented, approving tax refunds and approving the moving of accounts to uncollectible roll;
8. Consider status of insurance and FEMA claims relative to Hurricane Harvey damages;
9. Operator's Report, including:
 - a) Appeals of District charges;
 - b) Refer accounts for collection and approving write-off of uncollectible accounts; and
 - c) Report regarding status of maintenance projects, and the taking of any actions in connection therewith;
 - d) Approval to rescind Stage 1 of Drought Contingency Plan;

11. Engineer's Report, including:
 - a) Report concerning bids and/or award of construction contract or concurrence in the award of a contract for the construction or repair of water, sanitary sewer, drainage and recreational facilities within the District; status of construction contracts, including the approval/concurrence of any change orders and/or acceptance of

- i) Status of construction contract with CFG Industries, LLC for clarifier repairs at the Wastewater Treatment Plant;
 - b) Status of the North Harris County Regional Water Authority (“Authority”);
 - c) Report on operation of flare from Patriot and approval of amended contract in connection with same;
 - d) Report regarding maintenance of park property and trails and consider authorizing repairs relative to same;
 - e) Consider review of quotes for replacement of booster pump no. 1 at Water Plant;
 - f) Consider status of permit renewal for WWTP Discharge Permit; and
 - g) Consider update on Microgrid implementation;
